ANNUAL REPORT

PART ONE

The 12 month period between Thanksgiving 2016 and 2017 has been very busy and quite costly, especially for LEGAL DEFENSE of our foundation and ILLEGAL PROPERTY TAXES IMPOSED BY CORRUPT CENTRAL APPRAISAL DISTRICTS IN WALKER AND SAN JACINTO COUNTIES.

Major works in progress or works completed included:

1. Making as many woods roads, aka fire breaks, aka Jeep trails as Lexus friendly or at least truck friendly as possible.
2. We burned several hundred acres which is quite labor intensive but which produced positive results.
3. When we agreed to allow Geyata to live at no personal expense except for her to pay her power bill to live on the new 500 acres, we spent a great deal of money to restore the trailer on site and to build her a new office. In return she donated \$10,000 to the foundation.
4. We had a number of scientists visit and paid twice for Fran James, the alleged foremost RCW expert to come for a visit and give a talk at SHSU. I was her personal tour guide and we visited with the Sam Houston National Forest Supervisor and told him about our "Sawmill Museum" and hopes that he would protect the 1,400 acres of National Forest between US 190 and the SHSU Field Station so that we could eventually donate the Saw Mill Museum to SHSU and/or the USFS.
5. A major undertaking was converting Gamers Grove into our CHILDRENS MUSEUM, said task being successfully completed and

with success in implementing FREE programs for children and their parents every Sunday afternoon.

6. A 1,000 square foot deck for safe children's play was constructed to connive the current Childrens Museum with the "Rather House" which is currently planned to become a CHILDRENS MUSEUM OF ETHNOGRAPHY and WORLD CULTURES.
7. The "Curator" of the Childrens Museum was supposed to apply for funding from the foundations run by personal friends and also to pay the utility bills on the museum where we built her a first class apartment but so far our foundation (aka Sue and I) are footing all of the bills associated with all of the museums and wildlife sanctuaries.
8. We have hosted several other scientists including clam specialists, snail specialists, Dr. Pickering of "Discover Life" of SHSU and The University of Georgia, the founder of The Old Growth Forest Network who gave a talk at the Museum of Gene-o-Cide, aka Sawmill Museum.

PART THREE

The \$100,000 donation to the foundation to help cover the cost of managing the church's 1,000 acres of wildlife sanctuaries and botanical preserves was the greatest one time single expense followed by the huge legal expenses associated with protecting our church properties from HATE CRIMES COMMITTED BY WATERWOOD IMPROVEMENT ASSOCIATION

including hatred of our Veterans Cemetery and hatred of GOD'S HOLY CREATION and the destruction of church owned rare orchids and over 130 other native species.

A major blow to church property was the forced sale of the church parkway at an estimated loss of \$250,000 plus the destruction of God's Holy Creation as protected by the church.

Another huge legal expense was the corrupt acts and actions of WIA and WIA'S corrupt attorney to convince a judge that I should be thrown in jail for legally, under State Law marking our church properties with purple paint after \$30,000 worth of our rare trees had been destroyed and I was the victim of 3 felonies by the criminal who destroyed the trees, assaulted me, stole the evidence and fled from the cops only to be set free by the corrupt Constable.

The other major expenses of the church were associated with tractors and other vehicles in the church fleet, the purchase of the security bus to be stationed at the chapel, and utilities and maintenance.

PART FOUR

As The Ethician Foundation manages Ethician Church wildlife sanctuaries and botanical preserves for a "donation" from the church we include major church expenses as well in this report.

Part Four of this report includes expenses of \$1,000 or more but does not include expenses for administrative overhead.
