At 11:00 AM a meeting of the Ethician Foundation Board was held in Waterwood, Texas at Pelican II: The Institute for Strategic Biospheric Studies

The meeting was called to order by GHR at 11:15 a.m..

GHR reminded non board members present that they may comment but are not permitted to vote.

Minutes of prior meeting on 23 Nov 2018 were read, and JRM made a motion to approve minutes for the record.

MAR seconded the motion. The vote was taken and it was voted unanimously to add minutes to the record.

Next, GHR introduced an Annual Report for foundation activities and challenges during 2019.

Report was read (report attached as addendum).

### ETHICIAN FOUNDATION BOARD MINUTES 29 NOV 2019

GHR introduced discussion points which had been submitted to the board prior to the start of the meeting. He asks board members to consider these important questions prior to next meeting.

#### GHR introduced these as follows:

- 1. How to expose WIA for its continuous crimes against our foundation and our church.
- How to sustain our foundation and church financially.
- 3. Determine who will manage and sustain museums and wildlife sanctuaries and Institute upon the demise of President GHR.

GHR introduced proposed acquisitions to the Foundation as follows:

#### BOOKLAND PROPERTY:

GHR moved to attempt acquisition of old Bookend building on University Ave. as a cornerstone to the museum district of EF. The goal would be a museum store in the building to offset EF expenses. GHR anticipated an appraisal not in excess of \$200,000.

MAR moved to approve a purchase of the Bookland property provided price was at or below \$200K.

#### SBR seconded the motion

A vote was taken and a unanimous agreement was made to authorize purchase of property within budget.

#### BAYHILL PROPERTY

The owner of the property next-door to the Insitute on Bay Hill Road has died and spouse in a care facility. GHR requested a motion to enter into discussions with heirs to acquire the property as a protection of native prairie and Spanish moss covered grove, as well as to assure parking and access to Institute.

JRM made a motion to authorize acquisition of property, if available.

GAR seconded the motion and a unanimous vote resulted and the motion was passed.

It was determined that there was no additional business to discusss.

MAR moved to adjourn the meeting.
